FORMULATION GUIDELINES

RECOMMENDATIONS FOR USE

SYNOCURE® 9279 S 65 should be mixed with the selected polyisocyanate just prior to application. The mixing ratio is not critical although it is preferable to use stoichiometric ratios to obtain optimum performance.

The reaction ratio is calculated from the respective equivalent weight or hydroxyl and isocyanate content of the reactants.

The relationship is:

Hydroxyl Equivalent Weight = $(17 \times 100) / \%OH$

Isocyanate Equivalent Weight = $(42 \times 100) / \%NCO$

Using Tolonate™ HDB 75 MX ⁽¹⁾, the recommended ratios would be:

- on solid resins: SYNOCURE® 9279 S 65/Tolonate™ HDB 75 MX ⁽¹⁾ = 400/191

- as supplied: SYNOCURE® 9279 S 65/Tolonate™ HDB 75 MX ⁽¹⁾ = 615/255

SOLUBILITY

The solvents chosen for paints and lacquers based on SYNOCURE® 9279 S 65 used should be free from water and not contain groups that react with isocyanates. Esters and ketones are true solvents and are recommended for use in combination with aromatic hydrocarbon diluents such as xylene.

STORAGE AND HANDLING

SYNOCURE® 9279 S 65 should be stored indoors in the original, unopened and undamaged container, in a dry place at a temperature not exceeding 30°C. Exposure to direct sunlight should be avoided.
